DuraCoat ™ II Catalyst is packaged in 3.2 oz containers for single gallon (125 oz.) and 16 oz. containers for 5 gallon pails (625 oz.). Add entire contents of the proper size, pre-measured bottle of DuraCoat™ II Catalyst to catalyze the entire container of DuraCoat™ II Post-Catalyzed clear or white topcoats. Stir material while adding catalyst and continue to stir until thoroughly mixed. Material is now ready for spraying.

Notes: The entire container of DuraCoat II Post-Catalyzed clear or white topcoats must be catalyzed at once. Do not catalyze partial amounts. Attempting to catalyze partial amounts may result in poor performance of the product.
